WHAT IS THE PURPOSE AND LEGAL BASIS OF PROCESSING

- 3) determine, protect and enforce any of our rights, including assignment of claims against you to third parties, for the time no longer than limitation period - on the basis of article 6 par. 1.f GDPR (hereafter referred to as "legitimate interest"); or for the time necessary to carry out obligations regarding evidencing of transactions - on the basis of legal obligation.
- 4) **carry out summaries, analysis, statistics**, for the time necessary to carry out such activities on the basis of legitimate interest;
- 5) direct marketing, for the duration of a contract on the basis of legitimate interest.

 - b) couriers and post offices;
 - c) payment institutions to process any payments from or to you;
 - d) assignees in case of assignment of claims that we may have against you;
 - e) government authorities, judiciary, local authorities if it is necessary under applicable laws.

YOUR RIGHTS
